

Operational Lighting

Subject: Procurement Report

Date: 8th March 2018

Reference: HWFRS/39

1. Background

Hereford and Worcester Fire & Rescue Service (HWFRS) are revising our lighting strategy for front line appliances and special appliances.

HWFRS operate 41, front line rescue appliances (large fire engines), as well as 11 additional large fire engines for training, Young Firefighters and fleet reserves.

The lighting is used at all types of operational incidents and as such is exposed to adverse environments.

HWFRS current lighting provision consists of hand lamps (both waterproof and standard), BA torches, Officer's torches (including Fire Investigation), scene lighting (including technical rescue provision) and an enhanced capability on the Incident Support Vehicle (ISV).

Historically an appliance has four ATEX rated hand lamps, one wide area Officer in Charge lamp and two scene lights the lockers.

During this process we will be considering options for other lighting provisions across the service with a view to streamlining the number of different models currently in circulation.

2. Service Review

The review of our current lighting provision was done through and engagement/consultation with service delivery via the Fleet Equipment Steering Group (FESG) on their operational requirements. Market research has been conducted to explore the most recent advances in technology and suitability of products to meet the User Specification.

The option for a collaborative procurement was explored however this was not a viable option as:-

- Shropshire FRS are looking at rolling replacement for hand lamps and scene lighting for new appliances. As such they will be looking at the respective lots.
- West Midlands FRS has recently renewed their lighting provision for their new appliances so are not looking to procure.
- Warwickshire have recently replaced their BA and fire ground torches so are not looking to procure.
- HWFRS have a MoU for use of scene lighting with West Mercia Police and they have also shown an interest in the hand lamp Lot.

As part HWFRS review and finalising the process the following documents were agreed.

Finalising of Tender Documents

- 1. Invitation to Tender, Evaluation Criteria, Specification, Questionnaire Appendix 1
- 2. Pricing Schedule Appendix 2

The specification was agreed by the equipment's project officer, equipment manager and service delivery representatives and included the following headings:-

- Quality (40%)
- Availability, Delivery and Performance (30%)
- Price (30%)

The Authority requires a one off purchase of the following lighting. The requirements have been split into Lots as indicated below.

(Suppliers may submit responses for one, for several, or for all Lots. <u>Suppliers may offer more than one light option in each Lot</u>, providing that those lights offered meet the requirements. Suppliers may be awarded Contracts for one, for several or for all Lots).

3. Procurement

The Tender for supply of Operational Lighting was advertised on 20th February 2018, with a closing date for applications on 2nd March 2018.

This was undertaken as a mini competition through Lot 5- Lighting of the YPO Framework Agreement- 515 Emergency Response Equipment.

4. Evaluation Stage

Evaluation Stages

- Stage 1- Evaluated Price (30%)
- Stage 2- Evaluated structured response to questions; Quality (40%) and Availability, Delivery and Performance (30%)
- Stage 3- No amplification/clarification requested

Evaluation questions were based on the following overarching criteria and weighted scores:

Award Criteria	Weightings

Quality	40%
Availability, Delivery and Performance	30%

Only 2 bids were received from the suppliers listed below.

Suppliers

- 1. Safequip Ltd
- 2. Night Searcher Ltd

Stage 1- Price (30%)

A full cost evaluation was carried out on both of the suppliers returned pricing schedules based on the one off purchase of each Lot.

Stage 2- Quality (40%) and Availability, Delivery and Performance (30%)

The suppliers tenders submissions were reviewed against the above criteria and specification (**Appendix 1**) with the evaluation panel consisting of Equipment Manager and Procurement and Contracts Manager, agreeing, through consensus, an overall score for each question.

Nightsearcher Ltd are appointed for the supply of Lot 2, Lot 3, Lot 4, Lot 5

6. Savings Achieved

Lighting for Operational Incidents (Nightsearcher and Safequip).

Allocated budget was £90,000 Actual price was £58,124.83 Calculations of the savings £90,000-£58,124.83 =£31,875.17

Own procurement cost process estimated at 10 days worth of effort at £150 per day. Use of framework resulted in 4 days at £150 per day therefore a 'non cashable' savings of £900 can be demonstrated (saved 6 days at £150 per day= £900)
