

# Server Hardware

## 1. Background

Hereford & Worcester Fire and Rescue Service (HWFRS) have developed an ICT Strategic Programme, which will deliver the requirements set out in the 2017 ICT Strategy, to increase productivity through flexible and accessible systems, whilst delivering continued cost savings. See **Appendix 1** ICT Strategy 2017 for full strategy.

HWFRS must keep pace with modern, user-oriented models of operating in order to address changes in the expectations of our workforce and providing our communities with sustainable, high quality firefighting, rescue and preventative services.

The government has mandated Public sector bodies look at collaborative ways of cutting costs through shared services. The Authority has made the decision to forge closer ties with Warwickshire Police & West Mercia Police (WP&WMP). One result of these initiatives is that the Authority has agreed to co-locate its SHQ with the WP&WMP at their site in Hindlip.

Following a series of technical design workshops, server architecture has been agreed to allow services to be provisioned at the new location. The new architecture has also been designed to fit in with existing infrastructure and equipment. As a result, specific lists of server hardware items are required to deliver the new service. Additionally, a number of enhanced support warranties may also be required for the new server hardware.

This document aims to provide a clear and transparent rationale for how the appropriate supplier has been selected to provide the Server Hardware. The Service has assessed the appropriate procurement routes, the appropriate available partners and the relevant costs of those partners.

# 2. Service Review

HWFRS consists of, in addition to its headquarters (SHQ), 27 fire stations strategically located across the two counties. Nineteen of these stations are Retained and predominantly located in Hereford. The remaining 8 stations consist of 3 day crewed and 5 whole time.

The chosen solutions will meet the aspirational goals of the Authority to deliver a modern ICT service that is resilient, effective and scalable.

Based on the deliverable the Project Officer and Head of ICT reviewed and agreed based on the Authorities operational requirements a user specification inline with current legislation.

As part HWFRS review and finalising the process the following documents were agreed.

The specification structure was agreed and the following criteria would be used to assess the overall economic advantages of the tender proposals:-

- Price (75%)
- Quality (25%)

The Authority requires a one off purchase for the hardware with warranties.

## 3. Procurement

The Tender for the provision of Server Hardware and Warranties was advertised on 1<sup>st</sup> June 2018, with a closing date for applications on 21<sup>st</sup> June 2018.

This was undertaken as a further competition under the Crown Commercial Services Agreement RM3733 Technology Products 2 - Lot 1- Hardware, via the Bluelight EU Supply e-Tendering Portal. Crown Commercial Services (CCS), a national public sector procurement, offers a wide range of options and suppliers with heavily discounted public sector specific products. This framework also significantly reduces the costs and capacity otherwise required to undertake a full procurement (tender) process. This framework complies with all appropriate and relevant legal requirements.

## 4. Evaluation Stage

Evaluation Stages

- Stage 1- Evaluated Price (75%)
- Stage 2- Quality (25%)
- Stage 3- No further clarification/amplification were requested by HWFRS

# Stage 1- Price (75%)

A full cost evaluation was carried out on all of the suppliers returned pricing schedules based on the hardware purchase price and warranties.

# Stage 2- Quality (25%)

The suppliers tenders submissions were reviewed against the above criteria and specification (**Appendix 2-3**) with the evaluation panel consisting of Project Officer and Head of ICT, agreeing, through consensus, an overall score for each question.

The below table summaries the weighted scores achieved by each of the four suppliers

# 5. Recommended Decision

Insight Direct UK Ltd is appointed for the provision of Server Hardware and warranties. Contract Value would be £114,731.22 (one off purchase) which will commence 6<sup>th</sup> July 2018.

HWFRS will benefit from using the CCS Framework as it is: quick and easy to use and no sign up fee and discounted products/services.
